**WHERE:** **LINE-UP ON Crete Boulevard (via Burville Road).** From Main Street in Crete, turn east on Burville Road by Smokey Jo's and parade officials will direct you toward your line up spot on Crete Boulevard. Please do not turn onto Crete Boulevard directly. Parking will be available on surrounding streets. After you park your vehicle, please pick up your registration number at the Station on the corner of Wood Street and Crete Boulevard. It is important to get your number!

**GUIDELINES:** Use LOTS of LIGHTS! Music makes a great addition. Use sturdy materials. Dress warmly. Make sure your name (business or organization) is clearly visible. No candy or other items may be thrown - items must be distributed by walkers along the edge of the street.
